

**The purpose of this document is to ensure that all parents/guardians of the players and players participating in any DG WARRIORS program are made aware of and agree to our CODE OF CONDUCT involving parents and fans. Each parent/guardian and player must sign the CODE OF CONDUCT. The DG WARRIORS will not tolerate hostile and disruptive behavior by coaches, parents, players or fans. Failure to observe the parent/player CODE OF CONDUCT could result in forfeiture of your child's participation in any DG WARRIORS program, including tournaments, practices, and skill development clinics and sessions.**

### **PARENT/PLAYER PLEDGE**

1. I hereby pledge to provide positive support, care, and encouragement for my child's participation in the DG Warriors club. I understand that the needs of the team are bigger than the needs of me and that success of the team is bigger than the success of any individual.
2. I will encourage good sportsmanship by demonstrating positive support for all players, coaches and officials at every game, or practice. Therefore, as a parent or fan, I will not harass, abuse, disrespect, or cause a disturbance against any coaches, players, or officials.
3. I will place the emotional and physical well-being of my children ahead of my personal desire to win.
4. I will demand a healthy sports environment for my child that is free from drugs, tobacco, and alcohol and likewise will refrain from their use at DG Warriors youth sports events.
5. I will remember that my child's game is for youth – not adults.
6. Both my child and I will treat other players, coaches, fans and officials with respect regardless of race, sex, creed, or ability.
7. I will assure transportation and support the attendance & prompt arrival of my child to all practices and games. I will communicate, in advance, if my child is unable to attend a practice or game.
8. I will guarantee payment of all fees. I understand that these fees must stay current in order for player participation in practices and games.
9. I won't approach my child's coach directly before, during or after a game. I'll wait 24 hours before addressing concerns; I'll meet with the coach first before contacting DG leadership. I understand the coach will only discuss concerns involving my child, not another team member.
10. I will not be a distraction in any form before, during, or after a game. I understand that all team members will be expected to stay focused on the game plan and must listen to the coach's instruction before, during, and after games.

### **IF I FAIL TO ABIDE BY THE GIVEN CODE OF CONDUCT, I UNDERSTAND THAT THE CONSEQUENCES COULD INCLUDE, BUT NOT LIMITED TO THE FOLLOWING:**

1. Verbal warning by official, team coach, and/or Director of the DG Warriors Club
2. Written warning by team coach and/or Director of DG Warriors Club
3. Parent game suspension with written documentation of incident kept on file by DG Warriors
4. Dismissal from participation as members of the DG Warriors Club
